The State of New Mexico requires all farm equipment and livestock to be reported to the County Assessor’s office for tax purposes and shall be reported as of January 1st of each year. Livestock that is in New Mexico for a portion of a tax year exceeding twenty days is subject to Ad Valorem tax at a pro-rated value as per Subsection D of Sec 7-36-21. All returns are subject to audit and only equipment that is reported on your Federal Income tax return is taxable. You must submit a copy of supporting documentation for all depreciated equipment.

Failure to report, will result in a 5% non-remittance penalty.

All livestock located in any county in the state of New Mexico must be reported regardless of use. Months in county means number of month's livestock will be in the county for the current tax year only. Common livestock is defined as any animal without registration papers.
