WHEREAS, the Board of County Commissioners has established various boards and advisory committees to assist with the management of County business; and,


WHEREAS, on January 5, 2022 this Board approved Resolution 2022-09 appointing the board and committee members of the Valencia County Commission; and,

WHEREAS, the Commission has determined that Resolution 2022-09 requires amendment to fill current vacancies on its boards.


