**INSTRUCTIONS – AGRICULTURAL LANDS AND LIVESTOCK:
 SECTION 7-36-20 and 7-36-21**

The value of land used primarily for agricultural purposes shall be determined on the basis of the land's capacity to produce agricultural products. Objective evidence of bona fide agricultural use must be produced for the land to be valued as agricultural land. "Agricultural use" means the use of land for the production of plants, crops, trees, forest products, orchard crops, livestock, poultry or fish. Agricultural lands as the term is used include grazing land. Applications for agricultural lands and livestock must be received by the Assessor's Office **no later than the last day of February** or the account is subject to late fees.
