**APPOINTMENT/ RATIFICATION OF JUVENILE JUSTICE BOARD**

**WHEREAS**, the Board of County Commissioners met in a regularly scheduled meeting on Wednesday, March 18, 2015 at 5:00 p.m. in the Valencia County Administration Building 444 Luna Avenue, Los Lunas, New Mexico 87031; and,

**WHEREAS**, the Board of County Commissioners has general authority to provide for the appointment and removal of volunteer advisory boards; and,

**WHEREAS**, the Valencia County Juvenile Justice Board has been in existence and serving Valencia County youth and families since September, 2010 and in 2014 the Board of County Commissioners formally adopted the Juvenile Justice Board's organizational document with the approval of Resolution 2014-10 on January 15, 2014; and,

**WHEREAS**, the County Commission Established the Valencia County Juvenile Justice Board, per the federal Juvenile Justice and Delinquency Prevention Act of 1974, which develops juvenile justice alternatives to detention; graduated sanctions programs as needed in the community and other youth oriented programs; and,

**WHEREAS**, the all-volunteer board is composed of leaders from all sectors of the community, including city and county government, churches, law enforcement, juvenile justice, schools and business; and,

**WHEREAS**, section 6 of resolution 2014-10 provides that there shall be 11 members of the Juvenile Justice Board appointed by the Board of County Commissioners for a term of two (2) year; and,


**NOW THEREFORE, BE IT RESOLVED**, by the Valencia County Board of County Commissioners that the following appointments to the Valencia County Juvenile Justice Board are hereby made, whose terms shall expire the first day of April 2017:




